
Narrative

ARREST REPORT NARRATIVE

On 02/11/2024 I (Deputy A. Howard) responded to 40 Montford Ct, in Cameron NC in reference to a Warrant Service. Upon my arrival, pending investigation David Davis was placed under arrest.

He was transported to the Harnett County Detention Center and served with 4 outstanding warrants. He was then given a court date of the 8th of March 2024 for the Moore County charges, along with a court date of the 13th of February 2024, for the Cumberland County Charge.

His bond was set at \$15,000.00 for the Cumberland County charge, and \$12,000 for all three Moore County charges. No further.
