ARREST REPORT NARRATIVE

On 03/20/2024 at approximately 0055 hours, I was assisting a Deputy on a traffic stop, where I observed a grey in color vehicle (TMZ5048) failed to yield to blue lights (G.S 20-141.5(A), The vehicle (TMZ-5058) then sped off at a high amount of speed over 85 MPH in a 55 MPH zone (G.S 20-141(A) and fail to stop. Upon making contact with the driver, I discovered that the driver did not have a valid driver's license (G.S. 20-7(A)).

The vehicle stopped at 57 Zachero St Cameron in a high drug area; The subject was detained, and the vehicle was searched. Upon searching the vehicle Deputy Campo-Laboy and I found a Clear in a colored baggie containing a white powdery substance that appeared to be Fentanyl, The Clear in the color baggie was in between the center of the driver and passenger area. The subject listed above was arrested for Possess Schedule II Controlled Substance (G.S.90-95(A)(3). The subject was transported to the Harnett County Detention Center where he was booked and processed.
