#### ARREST REPORT NARRATIVE

On Tuesday, April 23, 2024 at approximately 1420 Hrs, I, Detective Abate arrested Jonathan Gilbert JOHNSON for felony possession of a schedule II controlled substance (fentanyl), possession of a firearm by a convicted felon, and possession of drug paraphernalia at the Harnett County Detention Center where he is currently confined for a probation violation.
