ON 04/09/2019 I, DEPUTY LISEK AND DEPUTY HALEY RESPONDED TO 1659 BUFFALO LAKE ROAD, SANFORD NC TO INVESTIGATE AN UNCONSCIOUS PERSON. UPON ARRIVAL WE MADE CONTACT WITH JASON BRANDON WHITE (SUSPECT) WHO WAS UNCONSCIOUS BEHIND THE WHEEL OF A PARKED MOTOR VEHICLE. FURTHER INVESTIGATION REVEALED THAT WHITE WAS IN POSSESSION OF HEROIN AND DRUG PARAPHERNALIA MR WHITE WAS PLACED UNDER ARREST AND TRANSPORTED TO HARNETT COUNTY DETENTION CENTER, WHERE HE WAS TAKEN BEFORE THE MAGISTRATE FOR FURTHER
