III POSSESSION OF STOLEN PROPERTY.

THIS ARREST STEMMED FROM AN INVESTIGATION WHEREBY THE OFFICE OF THE HARNETT COUNTY SHERIFF WAS CONTACTED BY MS. STEWART, WHO INDICATED THAT HER STORAGE FACILITIES HAD BEEN BROKEN INTO MULTIPLE TIMES THROUGHOUT THE PAST TWO WEEKS, AND SHE HAD CONFRONTED AND PHOTOGRAPHED A MAN PILFERING THROUGH SEVERAL ITEMS NEAR THE OUTSIDE OF THE STORAGE FACILITY. SHE INDICATED THAT THE MAN'S VEHICLE CONTAINED AN ABUNDANCE OF RANDOM ITEMS. SHE THEN REPORTED THAT AFTER CONFRONTING THE MAN, HE SUBSEQUENTLY ADVISED HER THAT "(HE) WAS TOLD THAT HE COULD TAKE WHATEVER HE WANTED." THIS INDIVIDUAL WAS THEN IDENTIFIED AS MR. BRUCE BARNES. A WARRANT FOR ARREST WAS DRAFTED SHORTLY AFTER THE IDENTIFICATION.

MR. BARNES WAS ARRESTED AND BOOKED UNDER A SECURED BOND OF \$5,000.00. HE WAS SUBSEQUENTLY PROVIDED A FIRST APPEARANCE COURT DATE OF APRIL 8TH, 2019, AT THE HARNETT COUNTY COURTHOUSE, IN LILLINGTON.
