LILLINGTON POLICE DEPARTMENT CHARGED SAID WARRANTS AFTER FINDING GEORGE IN HIS VEHICLE OF AN APPARENT OVERDOSE. GEORGE WAS TRANSPORTED BY EMS TO CENTRAL HARNETT HOSPITAL AND LATER RELEASED, AS HE HAD NOT BEEN TAKEN INTO CUSTODY.

GEORGE WAS LATER FOUND WALKING HOME FROM CENTRAL HARNETT HOSPITAL WHERE I ARRESTED HIM, PLACED HIM IN HANDCUFFS, BEHIND HIS BACK, DOUBLE-LOCKED, AND TRANSPORTED HIM TO HARNETT COUNTY DETENTION CENTER.
