**ARREST REPORT NARRATIVE**

August 10, 2021 (Tuesday)

At approximately 0821 hours, the defendant, Isaiah Avante McKoy turned himself into the Harnett County Sheriff's Office in regards to outstanding warrants for arrest stemming from an investigation whereby two individuals were shot at 68 Oakdale St. Coats, North Carolina. These warrants for arrest consisted of the following charges" Attempted First Degree Murder (2 counts); Assault with a Deadly Weapon Intent to Kill Inflicting Serious Injury (2 Counts); Discharge a Weapon into an Occupied Property Serious Bodily Injury (5 counts); Discharge a Firearm from an Enclosure (6 Counts); and Break and Enter with the Intent to Terrorize/Injure (1 count). The defendant was served and processed on these outstanding processes and was presented to the presiding magistrate, R. Holder. Magistrate R. Holder issued a no bond in regards to the 2 counts of Attempted First Degree Murder charges, a secured bond of \$1,000,000.00 on the remaining charges, and a first appearance court date scheduled for today (August 10, 2021).

The defendant was placed into the Harnett County Jail at this time without incident. The defendant was also entered in NCIC on these charges and will be removed from NCIC on this date and time.
