ARREST REPORT NARRATIVE

ON 08-02-2021 I DEPUTY COLLINSWORTH CONDUCTED A TRAFFIC STOP ON A BURGANDY IN COLOR GMC ACADIA DUE TO THE REGISTERED OWNER HAVING OUTSTANDING WARRANTS OUT OF HARNETT COUNTY. I TOOK THE DRIVER, A MS.
