ARREST REPORT NARRATIVE

ON JULY 3RD, 2021, MR DABNEY WAS ARRESTS AND TAKEN TO HARNETT COUNTY JAIL WITH REGARDS TO WARRANTS.

MR DABNEY WAS VERY FORTHCOMING WITH HIS ANGER ISSUES, BUT HE REMAINED CALM, POLITE, AND COOPERATIVE DURING THE WHOLE PROCESS.

MR DABNEY'S BOND WAS SET BY, B.HOYLE, FOR \$5000 SECURED BOND.
