Narrative

ARREST REPORT NARRATIVE

On this date, June 23, 2021 I had just cleared a call reference Break and Enter Place of Worship, Flat Branch Presbyterian Church located at 130 Darroch Road Bunnlevel NC. I was driving by Food Lion located at 8 The Square At Lillington on NC 210 South when I observed a white male subject fitting the description of the suspect who broke into the church at 2100 hrs. on 6/22/2021. I was able to identify the suspect from the ring camera located at the church. The suspect identified as Robert Wayne Masters DOB 7/7/1989 was wearing the same shorts and shoes seen on the ring camera and was carrying a black backpack similar to the backpack observed on the ring camera. Robert Wayne Masters also made spontaneous utterances that he pulled on the door at the church and it just opened. Robert Wayne Masters was placed under arrest and transported to the Harnett County Detention Center. I gave testimony before Magistrate C. Smith and probable cause was granted. Robert Wayne Masters was served with Warrant for Arrest charging Break and Enter Place of Worship and held under secure bond.
