<p>II-F-ATTEMPTED FIRST DEGREE MURDER.</p> <p>III-F-DISCHARGING A WEAPON INTO OCCUPIED PROPERTY/VEHICLE.</p> <p>THESE CHARGES STEMMED FROM AN INVESTIGATION WHEREBY THE OFFICE OF THE HARNETT COUNTY SHERIFF WAS CONTACTED ON WEDNESDAY, MAY 29TH, 2019, IN REGARDS TO AN "ASSAULT" CALL. A VICTIM WAS FOUND DECEASED AT THE SCENE OF THE CRIME; HOWEVER, ANOTHER VICTIM DID SURVIVE THE ASSAULT. THROUGHOUT THE INVESTIGATION, INVESTIGATORS FROM THE OFFICE OF THE HARNETT COUNTY SHERIFF FOUND "PROBABLE CAUSE" TO ISSUE A WARRANT FOR THE ARREST (WFA) OF THE DEFENDANT, ISIAH WILSON.</p> <p>THE DEFENDANT WAS ARRESTED WITHOUT INCIDENT IN CHARLOTTE (MECKLENBURG COUNTY), AND WAS SUBSEQUENTLY TRANSPORTED TO THE HARNETT COUNTY DETENTION CENTER, IN LILLINGTON. THE DEFENDANT WAS BROUGHT BEFORE THE HONORABLE MAGISTRATE, T.
