ARREST REPORT NARRATIVE

On October 14th at approximately 3:10am I, Deputy R. Henry, responded to a call for a suspicious vehicle at 25 Mary Grey Court.

While in route to the address I was advised by dispatch that the subject in the vehicle was possibly Madison Williams with warrants out of Wake county.

Upon arrival I could see a white in color Nissan Rouge parked in front of the residence. The vehicle was occupied by one black female in the driver seat and one black male in the front passenger seat. I approached the vehicle and made contact with the driver. I asked what the occupants were doing parked in the neighborhood at 3:30am to which the driver advised that she was waiting for her child. When I asked why she would be waiting for her child at 3:30am, she mumbled a response I could not hear. I asked how old her child was to which she replied "five." When asked again why she would be waiting for her five year old child at 3:30am she responded again by mumbling something I could not hear.

I asked the driver what her name was and she advised it was Madison Williams. I asked Ms. Williams what her date of birth was to which she originally replied [REDACTED] I asked if she had any form of ID on her to which she replied she did not. I then asked if she had any registration for the vehicle that she was driving and she looked in the glove compartment and then replied she did not have it on her. I asked her who's vehicle it was to which she replied "a friend." At that point Deputy L. Cupick arrived. At that point I asked Ms. Williams to step out and come to the back of the vehicle. When asked again about her birthday she again replied [REDACTED] I asked what her current address was to which she replied 6028 Namozine Court in Raleigh. I asked her again what she was doing in the neighborhood at 3:30am to which she replied with something I could not understand from her mumbling. At that point I asked her again what her date of birth was to which she had replied [REDACTED] I asked her to confirm the year to which she replied "I'm sorry [REDACTED]" I asked Ms. Williams to step back into her vehicle and keep the vehicle off.

I stepped to Deputy Cupick's vehicle to confirm that Ms. Williams did have unserved warrants. Deputy Cupick confirmed that she did have active warrants out of Wake County. At that moment I stepped back to the Nissan and instructed Ms. Williams to step out of the vehicle. She originally asked why she needed to step out of the vehicle to which I replied "because you have warrants and tonight you're going to be arrested and taken to jail." Ms. Williams did not step out so I again instructed her to step out of the vehicle. She again did not. I said to Ms. Williams "I'm not going to ask you again, step out of the vehicle." This time, Ms. Williams complied and she stepped out of the vehicle. At that point I arrested Ms. Williams with no further incident and transported her to the Harnett County Detention Center.
