#### ARREST REPORT NARRATIVE

**Date/Time:** 10/04/2024, approximately 2154 hours  
**Location:** Buffalo Lake Rd and NC 87 S  
**Arrested Individual:** Shelby Kejuan Smith  
**Charge:** Outstanding Felony Warrant (Guilford County) **24CR254851-400**

#### Narrative:

On October 4th, 2024, at approximately 2154 hours, I was conducting routine patrol at the intersection of Buffalo Lake Road and NC 87 South. While stopped at the traffic light, I observed a black Dodge Charger, bearing North Carolina license plate [REDACTED] that was positioned in the lane directly ahead of my patrol vehicle. As the traffic signal turned green, the driver of the Charger accelerated aggressively, causing the tires to screech loudly, an indication of reckless driving.

I immediately proceeded to follow the vehicle and observed it continuing to increase speed. Despite my efforts, the vehicle maintained a significant distance ahead of me, moving in a manner that made me feel as though I was stationary in comparison. I initiated a pursuit for approximately half a mile, during which I was able to pace the vehicle traveling at 68 miles per hour in a 55 MPH zone, in violation of the posted speed limit.

At this point, I activated my emergency lights and sirens to signal the driver to pull over. The vehicle complied, coming to a stop near the 1600 block of NC 87 South, in the Cameron area.

Upon approaching the vehicle, I made contact with the driver, who was identified via North Carolina Driver's License as Shelby Kejuan Smith. Upon running a check through dispatch, it was confirmed that Smith had an outstanding felony warrant out of Guilford County, North Carolina.

I proceeded to inform Mr. Smith of the warrant and placed him under arrest. I applied double-lock handcuffs and conducted a thorough search of Mr. Smith's person. No contraband or weapons were found on his person.

Mr. Smith was then transported to the Harnett County Detention Center without incident. Upon arrival, he was processed and booked by detention staff. Magistrate D. Dees was notified of the arrest, and Mr. Smith was presented before the magistrate for an initial appearance. Shelby Kejuan Smith's first court appearance in Guilford County is scheduled for 10/08/2024 at 0830 hours.
